MEMORANDUM OF UNDERSTANDING

BETWEEN

Al Quds Open University, a public university registered under the Palestinian Higher Education law No. 11 Act 1998, (License No. 1999/HEIB/08/09) and having its Headquarter address at Irsal St., Kanaan Blg., 4th fl., Ramallah, Palestine (hereafter called "QOU") represented by President Prof. Younis Amr acting under the Charter of the University

AND

Tambov State University named after G.R. Derzhavin situated in Tambov, Russia, hear office address Tambov, ul. Internatsionalnaya, 33 (hereinafter referred to as TSU) represented by rector, Prof. V.M. Yuriev, acting under the Charter of the University

With this Memorandum of Understanding, express their mutual aspiration for establishing and developing ties and contacts between the institutions in the areas of education, research and cultural exchanges.

THE PARTIES HAVE AGREED UPON THE FOLLOWS:

ARTICLE

The parties have agreed to collaborate in the areas of education, research and culture through

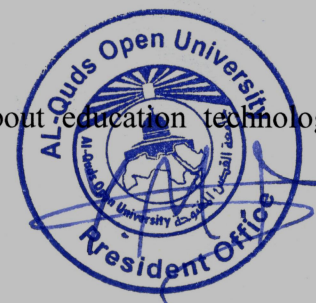
- 1.1. Student and faculty academic exchange programs.
- 1.2. Mutual invitation of scholars to conduct lectures and do researches.
- 1.3. Carrying out joint research projects.
- 1.4. Joint educational activities.
- 1.5. Exchange of information.

I. ARTICLE

The parties have agreed to create opportunities for QOU's Faculty of Administrative and Economic Sciences to acquire international education experiences help them to develop plan and carry out a tourism management program.

II. ARTICLE

The parties shall exchange experience and learn more about education technology included On Line and e Learning Tools (Virtual Classes).



III. ARTICLE

The parties shall exchange information, plans and learn more about education programs.

IV. ARTICLE

The parties have agreed to allow QOU's students to participate at TSU's Science Research Competition.

V. ARTICLE

The parties have agreed to develop a yearly joint electronic scientific publication.

VI. ARTICLE

TSU shall provide scholarships for QOU's faculty members and graduates to complete their masters and PhD degrees.

VII. ARTICLE

The parties have agreed to develop and manage an on line Arabic language course for none native speakers designed by QOU and another Russian language course for none native speakers designed by TSU.

VIII. ARTILCE

The parties shall exchange their delegations to coordinate interuniversity educational, research and cultural programs.

The coordination of work on the implementation of this agreement is done

at TSU by Dr. Rashid Razem.....

at QOU by Dr. Eng. Imad Hodali

IX. ARTICLE

This agreement is effective with the date of signing and is of unlimited duration. Each party has the right to terminate the agreement by giving a written notice to the other party at least one month prior to the contemplated date of termination.

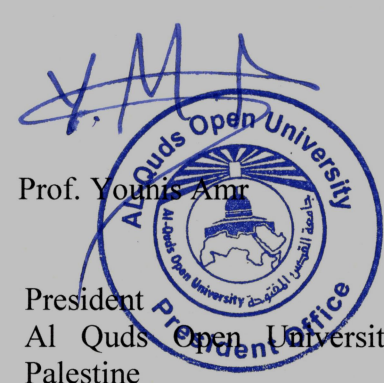
X. ARTICLE
